Federal Regulations require Catawba College to apply Title IV funds to qualifying charges only, such as: tuition/room/board, student fees, books, or other school supplies billed by the College.

Privacy of Educational Records and Access to Financial Aid Information

Once a student reaches 18 years of age or attends a postsecondary institution, he or she becomes the owner of his or her educational records, and all rights formerly given to parents/guardians under the Family Educational Rights and Privacy Act (FERPA) transfer to the student. FERPA prohibits Catawba College from releasing a student's financial aid records to anyone without the student's written consent, regardless of the student's age or who is paying the student's bills. While we enjoy the opportunity to assist your parents/guardians, we cannot discuss your financial aid without your permission.

If you want to change your permissions after you submit this initially, you **MUST** come to the Financial Aid Office to fill out an official form and will be required to show a valid, non-expired, government ID.

Federal Perkins Loan The Federal Perkins Loan is a low-interest (5 percent) loan for students with exceptional financial need as demonstrated by the FAFSA. New borrowers will be required to attend an entrance counseling session within the first month of class and sign a Master Promissory Note.

Presidential Scholarship In order to retain the Presidential Scholarship, you must maintain a cumulative grade point average of 3.0 and be enrolled full-time, which is 12 credit hours per semester as a Catawba student. The Presidential Scholarship also contains a \$1000 - \$2000 housing component for boarding students. Your grant is subject to reduction if you move off-campus.
