Summer Aid Enrollment Requirements

- You must be enrolled in at least 1 credit hour during the Summer term to be considered for Federal aid.
- If you are originally enrolled in 6 credit hours (half time) and then drop below half time, the Federal Direct Loans and the North Carolina Need-Based Scholarship will be canceled.
- If you drop a class on or after the first day of the class, you will be charged in full for that class.
- * If you do not enroll in the number of credit hours you indicate on this form, your financial aid will be adjusted. *

Summer Aid Eligibility

- Summer aid consists of remaining eligibility in Federal Pell Grant, Federal Direct Loans, and the North Carolina Need-Based Scholarship from the 2024-2025 academic year.
- **Pell Grant Eligibility-** Please be aware that you may only receive the equivalent of 6 full time semester of Pell Grant in your lifetime. By receiving Pell Grant in the summer term, you are using part of your lifetime limit and have the potential of running out of eligibility before you graduate. If you have questions or concerns regarding your remaining eligibility, please contact our office. *NOTE: If you have Pell Grant eligibility for 2024-2025, we MUST award you Pell per Federal Regulations if you are enrolled in at least 1 credit hour in Summer 2025. If you DO NOT want the Pell Grant for Summer 2025, you MUST DECLINE Pell at the bottom of this application.*
- North Carolina Need-Based Scholarship Eligibility (NCNBS)- You must be an official resident of North Carolina and have demonstrated financial need as determined by the FAFSA. Students must have also received the grant in the Fall/Spring to be awarded a Summer grant. You must be enrolled in at least 6 credit hours and attempt to complete those courses for the grant to pay for those classes.
- **Direct Loan Eligibility-** if you have borrowed the combination total of <u>Subsidized and Unsubsidized Direct Loans</u> listed below based on your grade level, you may <u>not</u> have any remaining eligibility unless....
 - You will progress a grade level after Spring 2025, from a freshman to a sophomore or a sophomore to a junior. Or your parent applies for a Federal PLUS Loan and is <u>not</u> approved. *You must be enrolled in at least 6 credit hours (half time) and attempt to complete those courses for the loan(s) to pay for those classes.*

Direct PLUS Loans for Parents of Dependent Students- If your parent wishes to apply for a PLUS loan for the Summer term, they will need to apply online at www.studentaid.gov and complete a "PLUS Loan Request Form" with the Catawba College Financial Aid Office.
